### Abetracte

#### Back to an Island of Tranquility in a Sea of Revolt? Limits of Brazilian Liberal Democracy Lúcio Flávio Rodrigues de Almeida

Brazil is experiencing its greatest movement of mass liberal democracy. Unlike other South American countries, in Brazil Lula's electoral victory, in a moment of declining mass mobilization, has made possible until now the creative recycling of neoliberalism, supported from the beginning by broad contingents of the popular classes and, in addition, by big domestic and foreign capital. We evaluate the possible scenarios in this context of apparent calm in the midst of a capitalist crisis whose evolution on both a global level and in Brazil is unpredictable.

#### The Social Sciences in Two Analytical Perspectives on Social Movements in Brazil Débora Cristina Goulart

This work presents a debate between two analytical perspectives from the social sciences on social movements in contemporary Brazil. One view takes as its point of departure the idea that the normalization and legitimation of publicstate spaces is a conquest of the movements and proposes the permanent enlargement of social reforms through a new political culture that works through state spaces and the cultural relations of the movements. Another current takes as its point of departure an analysis of the dynamics of social conflict and the class struggle and takes issue with the idea that participation in the government agenda reflects a definitive conquest for social movements. Researchers from these two currents construct analyses using different theoretical and methodological prisms and we attempt here to shed light on the debate between them.

We discuss the probable political and ideological implications of those conflicts for the proletarian struggles for social transformation.

#### Traditions of Labor Struggle and the Emergence of Movements of the Unemployed in Argentina

#### Davisson de Souza

This article explores the relationship between trade unionism and the emergence of the movements of the unemployed in Argentina in the second half of the 1990s. From the perspective of Marxist theory, it explores the explanatory potential of the concept of *relative overpopulation* and it analyzes the protests of the unemployed as an integral part of the labor movement. It presents an analysis of trade unionism today and it critically interprets the notion that unionism is giving way to "new social movements." The central hypothesis of this paper is that these organizations are heirs of the tradition of working class struggle in the country. To develop this idea it uses the theory of ideology and popular protest developed by the British historian George Rudé, particularly his concepts of inherent and derived ideas.
